

New Members. Membership Chair Marla Britton, SR/WA, presented two new members, Steven Lauenstein and Barbara Skibinski, with their membership plaques.

Secretary's Report: Beth Massey reported that the minutes were approved as they appeared in the First Quarterly newsletter. She offered a few highlights from the board meeting the previous night. Of note was that any changes to contact information should be provided to both the Chapter and Headquarters. There have been instances where a member has provided information to Headquarters and the information was not shared with the Chapter.

Greeters and Arrangers: Heidi Fischer. Heidi highlighted a few items from her report. Our June meeting will be held in Waupaca at the Best Western Grand Seasons Hotel and will feature a boat ride for the social event on Wednesday evening. Our 3rd quarter meeting will be held on September 1-2, 2010 at the Ramada Convention Center Hotel in Eau Claire.

Legislation: Bob Bokowski. Bob reported that there are two bills regarding survey issues that are making their way through the Legislature. Ernie discussed how, if passed, the bills would change how things are done for some utility companies. Legal descriptions are not necessarily written by surveyors for projects, instead the real estate specialists write the descriptions and seek to make them understandable to the property owner and the general public. Mike Halcarz added that utility companies are not in the business of subdividing property, which is what the legislative bills seem to be looking to regulate, rather, the utility companies are looking to complete their work in a timely and efficient manner.

Marla Britton presented information about an Assembly bill that was passed to require mandatory licensing of real estate appraisers, however, real estate brokers and salespersons were exempt from the requirement. The bill was passed on to the committee level at the Senate. The Senate committee chose not to take up the bill in this session.

Liaison : Jason Hogan. No report.

Membership: Marla Britton, SR/WA. Marla presented the list of eight new members but doesn't have certificates yet for all of them. Since there have been delays in receiving the certificates from Headquarters in the past, Marla will induct any new members who are present at

Relocation : Don Spenner, SR/WA and Reg Draheim, SR/WA. No report.

Right of Way Research: Lorraine Winchel. Lorraine discussed the deadlines for the 2011 Roster. It was agreed that we would order 275 again this year. Mike Halcarz motioned and Rick Dickson seconded that Lorraine order 275. Marilyn Smith said that lighter colors work better for the cover stock. Marla explained that there were some people who updated their information with International but the changes didn't make it in to the roster. Marla said it would be safest if a member were to contact BOTH Marla and International HQ to ensure that their contact information is current for the roster. Lorraine suggested that the Notice to Chapter Members be published in every newsletter so that everyone will know who to contact if their information changes.

Survey: Dave Karl. No report.

Transportation and Railroads:- Norman Pawelczyk. Norman reported information about the ARRA projects by dollars for 2009 and 2010 construction, and that the state was awarded \$823 million for high speed intracity passenger rail

Utilities and Pipelines : Mike Halcarz. No report.

Valuation : Norman Pawelczyk. No report. Webmaster - Debra Zimmerman. No report. However, there was a brief discussion from the floor that the website needs to be updated.

Region Report : Jerry Lund. Governance - Region chairs will become part of the governing Council at Calgary. Chairs will merge with the IEC to create the IGC, which will give Chairs

equal voting powers for certain Association issues. Most chapters have moved to the July - June FY. When the international directors are elected, they should be elected individually, not in tandem with their governance role in the Chapter. The designation task force is working on looking at various levels of certification.

Nothing has been decided yet. Auction item for the International Education Conference - Marla moved that we allocate \$350 to purchase an auction item(s) for the Calgary Conference. Rick Dickson second. Motion passed.

New Region 5 Secretary: A new secretary will be elected in Chicago. Brad Kraebel of Chapter 12 - Illinois will be nominated for this position.

Old business: Bylaw revisions - potential revisions are ongoing but no action was taken. Stand alone events - 17 of the 50 brewer tickets are currently spoken for. The tickets are on the 3rd base side and are regularly \$65 each, which the chapter is selling for \$45 each. Lorraine needs more volunteers to assist with the tailgate. It was agreed that Lorraine would keep all 50 of the tickets and that if any were unsold, other members would assist in reselling the tickets. Since it is a Cubs game, the prevailing sentiment was that the tickets would sell easily.

New business: There is a proposed bylaw revision pending with will accommodate the fiscal year change as requested by International Headquarters and the resulting change in officer terms. The information was published in the newsletter and it was agreed that we will vote on the issue at the general meeting tomorrow. COURSE 410: REVIEWING APPRAISALS IN EMINENT DOMAIN WAUPACA, WI - JUNE 2, 2010

Course Description: This course covers the importance and purpose of reviews in the eminent domain process, the types of reviews used in the marketplace, and the common mistakes found in reviews and appraisals. Sample types of reviews will be presented along with required disclosures, certification and limiting conditions. This course will conclude with an actual case study where participants will apply review techniques to a specific problem. As a result of this course, participants will be better equipped to answer the ultimate question, "Do the value conclusions make sense?"

Who Should Take This Course: This course is designed for staff appraisers who may be new to the profession, as well as for seasoned appraisers who want to improve the quality of their work. It is highly recommended that participants successfully complete IRWA Course 400 "Principles of Real Estate Appraisal," or equivalent, prior to attending this class.

Facilitator Richard F. Dickson is a review appraiser for the Wisconsin Department of Transportation. He has been with WIDOT for the past 16 years and has experience as a State-Wide Appraiser, Property Manager, and Litigation Coordinator. He has been an instructor for IRWA since 1991 and has taught a host of courses, including courses in both the Environmental and the Appraisal series. He has written the DOT Local Public Agency Manual, the Property Management Manual, and the Department's policy for the appraisal of contaminated properties. He has an excellent understanding of how to relate classroom instruction to your daily work needs.

**Course 209: Negotiating Effectively with a Diverse Clientele
Eau Claire, WI -- August 31-September 1, 2010**

COURSE DESCRIPTION: The objective of this course is to explore the dynamics for negotiating with a diverse clientele - the process, challenges and opportunities involved; the roots of misinterpretations that cause cultural collisions due to the dynamics of communication, behavioral prescriptions, assumptions, perceptions, values, reasoning styles, attitudes, language, social relations, ambiguity, orientations and patterns, formality, emotion; ethnocentrism; and to gain awareness of different negotiation styles/maximize one's personal negotiating power and effectiveness. 
